Evaluation:

None of the bidder has offered Generation 14 processors as requested due to the fact that it is new technology that is scarce in Africa, all bidder quoted for a generation 12 processor even though it is not current this will not affect the functionality of the computer, Therefore the BEC considered and recommended the goods offered.

The lowest bid for this item was submitted by PDC Performance Development Centre. The goods offered comply fully with the minimum specifications provided to Bidders and the price of **N\$ 1,775,280.00** is considered to be fair and reasonable.

It is recommended that **Item 1** be awarded to PDC Performance Development Centre.

None of the bidder has offered Generation 14 processors as requested due to the fact that it is new technology that is scarce in Africa .Even though the lowest bid for this item was submitted by PDC Performance Development Centre, Schoemans Technologies offered goods that are a later (Generation 13) and closer to the requested specifications (Generation 14) and comply fully with the other minimum specifications provided to Bidders. The price of **N\$ 233,822.60** is considered to be fair and reasonable.

It is recommended that **Item 2** be awarded to Schoemans Technologies.

Evaluation:

Even though the lowest bid for this item was submitted by PDC Performance Development Centre, Schoemans Technologies offered goods that are a later (Generation 15) and is higher than the requested specifications (Generation 14) and comply fully with the other minimum specifications provided to Bidders. The price of **N\$ 127,960.50** is considered to be fair and reasonable.

It is recommended that **Item 3** be awarded to Schoemans Technologies.

The lowest bid for this item was submitted by PDC Performance Development Centre. The goods offered comply fully with the minimum specifications provided to Bidders and the price of **N\$ 135,100.00** is considered to be fair and reasonable.

Evaluation:

The lowest bid for this item was submitted by PDC Performance Development Centre. The goods offered comply fully with the minimum specifications provided to Bidders and the price of **N\$ 556,777.50** is considered to be fair and reasonable.

It is recommended that **Item 5** be awarded to PDC Performance Development Centre

There was an adjustment on the bidding document to increase the number of Desktops by 14 to accommodate a late request by Rural Development for 14x Desktops. However the person that updated the bidding document did not update the number of licenses which led to the licenses requested being 14 less than what is needed.

Therefore the BEC is recommending that the PC grant approval to procure an extra 14 Microsoft Office 2021 for Home and Business Standard Edition licenses for the extra computer that were not included in the 122 procured licenses because the lack of office suite on computers, which includes Word, Power point Excel etc. If not installed, staff will not have access to the programs which will affect staff productivity

This additional expense will cost the Ministry an additional : **N\$ 65,000.00** which will bring the total to : **N\$ 621,777.50**
